The Ministry of Local Administration of Jordan (the "Employer") has received a financing from *Agence Française de Développement* ("AFD"), and intends to use part of the funds thereof for payments under the following Services: "Supervision of the design and construction works of the project '*Upgrading of AI Ekaider Waste Disposal Site – DBO*'".

#### Context:

The AI Ekaider site is located in the Northern Region of Jordan, in Mafraq Governorate, New Hosha Municipality, about ~21 km eastern to the city of Irbid and 0.5 km southern to the international borders with Syria (see Annex I / Figure1). It is located close to the main road connecting Irbid and Mafraq, at about 1.2km NE of the AI Ekaider village and 2.7km NW of the Mshairfeh village, which are the nearest villages to the site. The mean coordinates of the site are: 36°06.5'E and 32°30.7'N.




Figure 2: Location of major activities in the AI Ekaider site (Google Earth, 2016).

The AI Ekaider site has been in operation since 1981. It occupies an area of 908 donums (0,908km<sup>2</sup>), and is operated and managed by the Joint Service Council (JSC) of Irbid. Solid waste from residential, commercial, industrial, institutional, and agricultural generators, as well as sludge from wastewater treatment plants, industrial wastewater, and zibar (wastewater from olive-oil mills), which end up in the AI-Ekaider area for final disposal during all those years, have formed two discrete disposal areas have been respectively formed in the AI Ekaider site in 2016 (see Annex I / Figure 2):

- The dumpsite Area (A) in the northern part of the site; and
- The WW Evaporation Ponds Area (B) in the southern part of the site (including the zibar pounds in the western-south part of the Area).

The site's catchment area has been expanding during the years. With regards to the municipal solid waste (MSW) disposal, the site serves 31 Municipalities from four (4) Governorates (Irbid, Jerash, Mafraq and Ajloun), and the amount of MSW disposed is ~1,250 tones / day (average). With regards to the wastewater disposal, eighteen (18) evaporation ponds have been established in the site serving the whole Northern Region of Jordan. The wastewater quantities disposed in the ponds are not stable during one year nor for each year. It is roughly estimated that in 2016 a total 1,200 m<sup>3</sup>/d of wastewater treatment plants' sludge and mixed industrial wastewater was disposed of at the AI Ekaider ponds, in addition to approximately 130,000 m<sup>3</sup> of zibar.

Upgrading of AI Ekaider waste disposal site is a high priority project of the Jordanian Governement specified in the National Strategy for the Municipal Waste Management of Jordan, further studied at preliminary stage in the Regional Solid Waste Management Plan of Northern Jordan, and approved by the GoJ.




Figure 3: Ponds, Old Dumpsite, Phase B sanitary landfill, and Emergency Cells 1 and 2 included in the DBO Project (Google Earth 2018).
